--- Banning GMOs ----

Labeling is a MUST Banning sales of GMOs is possible Prohibiting GMOs in agriculture is needed

--- Agricultural Bans Are Best---

- Be aware that genetically engineered plants AND animals are released from laboratories, and into farm communities that are entrusted with growing plants and animals to be consumed as food. Prohibiting GMO crops and animals nips the GMO problem at its root.
- ----As early as 1998, up to 17% of U.S. dairy cows were injected with bovine growth hormone (called rBGH or rBST) to increase milk production. This practice leads to increased use of antibiotics to combat health problems caused by the GE hormone. http://www.sustainabletable.org/issues/rbgh/
- ---Animal feed is typically made from GMO plants. http://www.sustainabletable.org/issues/feed/
- Mendicino County, CA was the first municipality in the U.S. to ban GMO crops within its borders. If you desire to begin an agricultural ban initiative, please reach out to the organizers of this campaign, or to the contacts listed in this publication. Lessons learned include:
- 1. Do not go public too early with the campaign. The timing that worked in Mendicino was to begin public execution of the plan 2 months prior to the election. Don't give the opposition time to organize against you. (You will meet opposition from those who reside outside your community, and who benefit financially from GMOs.)
- Educate the community about GMOs: what are they? are they harmful? What has been done so
 far to address the problem and by whom? Invite speakers to give public presentations in the
 community.
- 3. Locate an advocate with political connections/familiarity with your jurisdiction.
- 4. Form committees, identify advisors and area coordinators. Expect to deal with all the people issues that come with bringing teams together - just work through them toward the project objective!
- 5. Draft the proposed legislation very carefully, and with expert advice, and then introduce it.

U.S. Supreme court will consider if Vernon Hugh Bowman infringed Monsanto's patents when he planted soybeans he purchased from a grain elevator. 94% of soybean crops in the U.S. are grown from GE seeds. Monsanto requires purchasers to sign a contract stating they will not use harvested seeds for planting, and acknowledging that these seeds are owned by Monsanto. United States: Mendocino, Trinity & Marin Counties in CA
Australia - banned in 1 state
Japan - seed ban, but imported canola seed from Canadian imports has been found growing New Zealand - Growing ban

Germany - ban cultivation or sale of GMO maize Ireland - cultivation banned in 2009
Austria, Hungary, Greece, Bulgaria & Luxembourg - all ban cultivation and sale France - Monsanto corn ban

Switzerland - ban crops, animals, plants
India - GM eggplant
Thailand - does both kinds of farming
